This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit Salvorias.com or any related media form, media channel, mobile website, or mobile application (collectively, the "Site").

This Site and our services, including the Salvorias Crypto Wallet, are designed for individuals and businesses aged 18 or older. If you do not meet these criteria, please discontinue use immediately.

By accessing or using the Site, you acknowledge you have read, understood, and agree to this Privacy Policy. If you do not agree, please do not use the Site.

We reserve the right to make changes to this Privacy Policy at any time and for any reason. We will alert you about any updates by revising the "Last Updated" date above. Continued use of the Site following any updates indicates acceptance of the modified terms.

### 1. Information Collection

#### **Personal Data**

We may collect personally identifiable information you voluntarily provide when you:

- Create an account
- Subscribe to updates
- Engage in community features (e.g., chat or message boards)
- Conduct business transactions

This may include:

- Full Name
- Business Name
- Shipping Address
- Email Address
- Phone Number
- Payment Details

Providing personal data is voluntary but may limit access to specific Site features if declined.

#### **Derivative Data**

Our servers automatically collect certain information when you visit, such as your IP address, browser type, device, operating system, pages visited, and access timestamps.

## **Digital Reward Wallet Transactions**

The Salvorias Wallet is a non-custodial DeFi wallet. We do not track, control, or store private keys, balances, or user-specific on-chain data. All blockchain transactions occur on public ledgers, and while immutable and transparent, they do not include personally identifiable details controlled by Salvorias.

Note: As blockchain transactions are irreversible and stored immutably, they cannot be deleted or modified even on request.

#### **Financial Data**

For purchases or transactions on the Site, payments are securely processed through trusted third-party processors (e.g., Stripe). Salvorias does not access or store full card details or banking information.

## **Sensitive Data**

We do not intentionally collect sensitive categories of data (such as biometric identifiers, health-related information, or government IDs). If such data is unintentionally collected, it will be promptly deleted.

## 2. Use of Information

We use collected information to:

- Provide and manage services efficiently
- Improve Site performance and user experience
- Process payments and issue confirmations
- Prevent fraudulent or unauthorized activity
- Enforce compliance with Salvorias policies
- Deliver updates and promotional messages (if opted in)

We do not track or monitor blockchain wallet transactions.

#### 3. Disclosure of Information

We may disclose personal information under the following conditions:

By Law or to Protect Rights

We may share user data as required by law, legal proceedings, or regulatory authorities.

Third-Party Service Providers

We may share limited personal information with service providers who support payment processing, cloud hosting, analytics, security, or marketing tasks.

#### Marketing Communications

- Within the Marketplace: Vendors may use basic data to personalize promotions.
- With Third-Party Partners: Trusted partners may receive limited information for marketing purposes with your consent.

You can withdraw marketing consent anytime by contacting us.

We never sell personal data.

Third-Party Cookies & Advertisers

We may use third-party analytics and advertisers that collect anonymized usage data for aggregated analysis or advertising.

## 4. Compliance with Privacy Laws

# General Data Protection Regulation (GDPR) - EU

EU users are entitled to the right to access, rectify, delete, or restrict data use, and to data portability and consent withdrawal.

## **Data Retention Policy**

We retain collected information only as long as necessary for the purposes described in this Policy, including legal, tax, and business requirements. Once retention is no longer necessary, data is securely deleted or anonymized.

## **Children's Privacy (COPPA Compliance)**

The Site and Wallet are not intended for users under 18. Any discovered minors' data will be deleted promptly upon identification.

# 5. Security of Your Information

We implement industry-standard safeguards, including SSL encryption, firewalls, and access controls, to protect personal data. While every reasonable effort is taken, no online data transmission is 100% secure.

# 6. User Controls, Do-Not-Track, and Universal Opt-Out

Salvorias currently does not respond to browser "Do-Not-Track" signals. However, users may:

- Disable cookies in browser settings
- Use token-level anonymization features in the wallet
- Opt-out of targeted advertising via privacy preference tools

Starting January 2026, Salvorias will honor Global Privacy Control (GPC) and Universal Opt-Out Mechanisms (UOOM) as required by U.S. state privacy laws.

### 7. Cross-Border Data Transfers

If your data is processed outside your home jurisdiction, safeguards are applied to ensure equivalent privacy standards, consistent with GDPR and U.S. regulations.
